SCHEDULES OF ASSETS AND LIABILITIES AND STATEMENTS OF FINANCIAL AFFAIRS GLOBAL NOTES AND STATEMENT OF LIMITATIONS, METHODOLOGY, AND DISCLAIMER REGARDING DEBTOR'S SCHEDULES AND STATEMENTS

The Schedules of Assets and Liabilities (the "Schedules") and Statements of Financial Affairs (the "SOFAs" and together with the Schedules, the "Bankruptcy Schedules") of the above captioned Debtor (the "Debtor" or the "Company") have been prepared pursuant to section 521 of title 11 of the United States Code (the "Bankruptcy Code") and Rule 1007 of the Federal Rules of Bankruptcy Procedure by management of the Debtor and are unaudited. The information provided herein, except as otherwise noted, is as of the close of business on February 5, 2015. While the Debtor's management has made every reasonable effort to ensure that the Bankruptcy Schedules are accurate and complete, based upon information that was available to them at the time of preparation, the subsequent receipt of information may result in material changes to financial data and other information contained in the Bankruptcy Schedules and inadvertent errors or omissions may exist. Moreover, because the Bankruptcy Schedules contain unaudited information which is subject to further review and potential adjustment, there can be no assurance that these Bankruptcy Schedules are complete or accurate. These Global Notes and Statement of Limitations, Methodology, and Disclaimer Regarding Debtor's Schedules and Statements (the "Global Notes") comprise an integral part of the Bankruptcy Schedules and should be referred to and considered in connection with any review of them.

- 1. The Debtor previously acquired all of the assets and certain liabilities of Church Street Health Management (f/k/a FORBA Holdings, LLC) pursuant to section 363 of the Bankruptcy Code, effective June 1, 2012. As a result thereof, the Debtor was deemed a corporate successor to FORBA Holdings, LLC, for purposes of that certain five-year Corporate Integrity Agreement ("CIA") by and between FORBA Holdings, LLC and the Office of the Inspector General ("OIG"), dated January 15, 2010. Pursuant to the terms of Section XI of the CIA, the Company became a successor in interest to the CIA. In this capacity, the Company previously managed 53 Small Smiles dental clinics in 19 states and the District of Columbia pursuant to various Management Service Agreements (each, an "MSA").
- 2. On April 1, 2014, the Company entered into an Exclusion Agreement (the "Exclusion Agreement") with the OIG of the United States Department of Health and Human Services, whereby the Debtor agreed to be excluded from participation in Medicare, Medicaid,

and all other Federal health care programs for a period of five years, effective September 30, 2014. In accordance with the Exclusion Agreement, the Company agreed, *inter alia*, to (i) shut down its operations in an orderly manner; or (ii) divest itself of all or substantially all of the CSHM Assets (as defined therein) through bona-fine, arms-length transaction(s).

- 3. In accordance with the Exclusion Agreement, the Company divested itself of substantially all of the CSHM Assets through a series of sales between April and September, 2014. Included among the sale of the CSHM Assets, the Company sold certain assets to First Quality Management, Inc. ("FQMI"), pursuant that certain Asset Purchase Agreement, dated as of September 30, 2014. Separately, the Company also entered into that certain Assignment and Assumption Agreement with FQMI, dated as of September 30, 2014, in connection with the assumption of six (6) MSAs.
- 4. Additional assets were sold to employees of the Debtor in September, 2014 in connection with shutting down its operations for proceeds exceed that quoted by liquidators. As set forth on SOFA question 10, certain asset sales occurred between a managed entity and a third party buyer, the proceeds of which were then used by the owner of the managed entity to settle or pay down the existing management fees that were owed to the Company by the seller. Simultaneously with this settlement, the respective MSA was then terminated and any remaining receivables were discharged by the Company.
- 5. The Debtor reserves all rights to amend the Bankruptcy Schedules, in all respects, as may be necessary or appropriate, including, but not limited to, the right to dispute or to assert offsets or defenses to any claim reflected on the Bankruptcy Schedules as to amount, liability or classification, or to otherwise subsequently designate any claim as "disputed," "contingent" or "unliquidated." Any failure to designate a claim as "contingent," "unliquidated," or "disputed" does not constitute an admission by the Debtor that such claim is not "contingent," "unliquidated," or "disputed."
- 6. The preparation of the Bankruptcy Schedules requires the Debtor to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities at the date of the Bankruptcy Schedules and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- 7. Some of the Debtor's scheduled liabilities are unknown and unliquidated at this time. In such cases, the amounts are listed as "Unknown." Accordingly, the Bankruptcy Schedules do not accurately reflect the aggregate amount of the Debtor's liabilities.
- 8. The Debtor reserves the right to change the attribution of liability from the Debtor to an affiliated entity to the extent additional information becomes available and amend the Bankruptcy Schedules without notice as applicable.
- 9. Given the differences between the information requested in the Bankruptcy Schedules and the financial information utilized under generally accepted accounting principles in the United States ("GAAP"), the aggregate asset values and claim amounts set

forth in the Bankruptcy Schedules do not reflect the amounts that would be set forth in a balance sheet prepared in accordance with GAAP.

- 10. The Debtor has excluded certain categories of assets and liabilities from the Bankruptcy Schedules, such as employee benefit accruals, post-retirement benefits, intercompany transactions between co-debtors, deferred taxes and deferred gains. Other immaterial assets and liabilities also may have been excluded.
- 11. It would be prohibitively expensive, unduly burdensome, and time-consuming to obtain current market valuations of the Debtor's property interests. Accordingly, to the extent any asset value is listed herein, unless otherwise indicated, net book values, rather than current market values, of the Debtor's interests in property are reflected on the applicable Bankruptcy Schedules. As applicable, assets that have been fully depreciated or were expensed for accounting purposes have no net book value. Unless otherwise indicated, all asset amounts and claim amounts are listed as of February 5, 2015.
- 12. Except as otherwise agreed pursuant to a stipulation or agreed order or general order entered by the Bankruptcy Court, the Debtor reserves the right to dispute or challenge the validity, perfection or immunity from avoidance of any lien purported to be granted or perfected in any specific asset to a secured creditor listed on Schedule D. Moreover, although the Debtor may have scheduled claims of various creditors as secured claims, the Debtor reserves all of its rights to dispute or challenge the secured nature of any such creditor's claim or the characterization of the structure of any such transaction or any document or instrument (including, without limitation, any intercompany agreement) related to such creditor's claim. The descriptions provided on Schedule D are intended only to be a summary. Reference to the applicable loan agreements and related documents is necessary for a complete description of the collateral and the nature, extent and priority of any liens. Nothing in the Global Notes or the Bankruptcy Schedules shall be deemed a modification or interpretation of the terms of such agreements.
- 13. The Debtor has not included on Schedule D parties that may believe their claims are secured through setoff rights, deposits posted by or on behalf of the Debtor, or inchoate statutory lien rights. To the best of the Debtor's knowledge, any such counterparties should be listed on Schedule F.
- 14. For purposes of the Schedules, the Debtor has only scheduled claims and executory contracts for which the Debtor may be contractually and/or directly liable. No claims have been scheduled for the Debtor which may have benefited directly or indirectly from a contractual relationship to which the Debtor was not a party.
- Schedule G regarding executory contracts and unexpired leases, inadvertent errors or omissions may have occurred. The Debtor hereby reserves all of its rights to dispute the validity, status or enforceability of any contract, agreement, or lease set forth on Schedule G that may have expired or may have been modified, amended, and supplemented from time to time by various amendments, restatements, waivers, estoppel certificates, letters and other documents, instruments, and agreements which may not be listed on Schedule G. Certain of the leases and

contracts listed on Schedule G may contain certain renewal options, guarantees of payment, options to purchase, rights of first refusal, and other miscellaneous rights. Such rights, powers, duties and obligations are not set forth on Schedule G. Certain of the executory agreements may not have been memorialized in writing and could be subject to dispute. In addition, the Debtor may have entered into various other types of agreements in the ordinary course of its business, such as easements, right of way, subordination, non-disturbance and attornment agreements, supplemental agreements, amendments/letter agreements, title agreements and confidentiality agreements. Such documents may not be set forth on Schedule G. The Debtor reserves all of its rights to dispute or challenge the characterization of the structure of any transaction, or any document or instrument (including without limitation, any intercompany agreement) related to a creditor's claim. In the ordinary course of business, the Debtor may have entered into agreements, written or oral, for the provision of certain services on a month-to-month or at-will basis. Such contracts may not be included on Schedule G. However, the Debtor reserves the right to assert that such agreements constitute executory contracts.

- 16. Listing a contract or agreement on Schedule G does not constitute an admission that such contract or agreement is an executory contract or unexpired lease. The Debtor reserves all rights to challenge whether any of the listed contracts, leases, agreements or other documents constitute an executory contract or unexpired lease, including if any are unexpired non-residential real property leases. Any and all of the Debtor's rights, claims and causes of action with respect to the contracts and agreements listed on Schedule G are hereby reserved and preserved.
- 17. The Debtor reserves all of its rights with respect to causes of action it may have, and neither these Global Notes nor the Bankruptcy Schedules shall be deemed a waiver of any such causes of action. Furthermore, nothing contained in the Bankruptcy Schedules shall constitute a waiver of rights with respect to this Chapter 7 case and specifically with respect to any issues involving equitable subordination and/or causes of action arising under the provisions of Chapter 5 of the Bankruptcy Code and other relevant nonbankruptcy laws to recover assets or avoid transfers.
- 18. In the circumstances where the Bankruptcy Schedules require information regarding insiders and/or officers and directors, included herein are the Debtor's (a) directors (or persons in similar positions) and (b) employees. The listing of a party as an insider is not intended to be nor should it be construed as a legal characterization of such party as an insider and does not act as an admission of any fact, claim, right or defense and all such rights, claims and defenses are hereby expressly reserved.
- 19. For purposes of Schedule B (16), the Debtor has no remaining accounts receivable. As set forth above, during 2014 all of the MSAs were settled with the owners of the managed centers and any remaining balance was written off.
- 20. For purposes of SOFA question 1, income is stated on an accrual basis. The Debtor earned management fee income from all of the managed entities, but did not receive a majority of the income. Rather, the income was offset by management fee expenses at the center level. During 2014, all of the Debtor's MSAs were settled with the owners and any

remaining balance was discharged. The termination fees were payments against the management fees owned and do not constitute additional income.

- 21. For purposes of SOFA question 3, the Debtor has excluded from SOFA 3(b) payments made to employees in the ordinary course of business. Further, certain payments to insiders in the 90 days prior to the Petition Date in response to question 3(b), are also included in the payments listed in response to question 3(c).
- 22. For purposes of SOFA question 3, outstanding amounts owed to such recipients of payments are listed in the Schedules.
- 23. For purposes of SOFA question 9, all payments made on behalf of the Debtor for consultation concerning debt consolidation, relief under the bankruptcy law or preparation of a petition in bankruptcy within one year immediately preceding the commencement of this case, was made through the Debtor's cash management system.
- The Debtor and its agents, attorneys and financial advisors do not 24. guarantee or warrant the accuracy, completeness, or currentness of the data that is provided herein and shall not be liable for any loss or injury arising out of or caused in whole or in part by the acts, errors or omissions, whether negligent or otherwise, in procuring, compiling, collecting, interpreting, reporting, communicating or delivering the information contained herein. While every effort has been made to provide accurate and complete information herein, inadvertent errors or omissions may exist. The Debtor and its agents, attorneys and financial advisors expressly do not undertake any obligation to update, modify, revise or re-categorize the information provided herein, or to notify any third party should the information be updated, modified, revised or re-categorized. In no event shall the Debtor or its agents, attorneys and financial advisors be liable or to any third party for any direct, indirect, incidental, consequential or special damages (including, but not limited to, damages arising from the disallowance of a potential claim against the Debtor or damages to business reputation, lost business or lost profits), whether foreseeable or not and however caused, even if the Debtor or its agents, attorneys and financial advisors are advised of the possibility of such damages.
